Purpose of the job

The focus of this role will be working on programmes and initiatives under the team's management, including the ECF and those announced as part of the recent Spending Review, such as the Investor Pathways Capital initiative. There may also be wider support on activities across the broader Investment Business, as required.

The ECF's principal point of contact with prospective fund managers whilst they are assessed within the ECF investment process and if successful throughout onboarding and portfolio management. This will be achieved by executing the main duties described below.

Main duties

The key aspects of the role will involve:

- Leading the critical appraisal of new fund investment proposals including in-depth analysis of team
 dynamics and suitability, track record, proposed investment strategy, financial terms and structure
 presented and sources of private capital.
- Being accountable for managing investment proposals for new fund investments through internal
 investment processes, e.g. reviewing investment papers and feedback, leading in calls and pitch
 meetings with prospective fund managers, overseeing due diligence activities on allocated deals and
 presenting proposals to Investment Committee.
- Lead the review of the investment legal documentation and negotiations with fund managers as required, to ensure consistency with the commercial terms agreed whilst liaising with internal teams and, specialist legal advisors.
- Managing a portfolio of venture fund investments as Relationship Lead, including activities such as attending advisory board meetings, communicating issues with stakeholders, dealing with matters arising (e.g. Investor Consents) and owning respective quarterly reporting requirements for allocated portfolio.
- Representing the team at wider stakeholder and ecosystem events and supporting deal flow generation efforts.

Knowledge and experience

Essential:

- Significant experience of working in a financial services role (fund management, investment banking, consulting, corporate finance, commercial lending or investment environment).
- An excellent commercial understanding of fund of fund investing and/or small business finances
- The role requires that the candidate should also have specific experience related to, or extensive knowledge, of the following:
 - o experience and commercial understanding of business transactions
 - o able to evidence excellent project/transaction management skills and
 - o have exceptional relationship management skills to a senior level
 - o ability to review and understand financial and investment analysis
 - lead on due diligence of proposals
